### 4. First-aid Measures

#### Description of first-aid measures.

##### **General advice.**

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice.

## 5. Fire-fighting Measures

**Extinguishing media.****Suitable extinguishing media.**

Use: Dry powder. Alcohol-resistant foam. Carbon dioxide (CO<sub>2</sub>). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

**Special hazards arising from the substance or mixture.**

## 6. Accidental Release Measures

Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Wear protective gloves/clothing and eye/face protection. Stop all work that requires a naked flame, stop all vehicles, stop all machines and equipment that may cause sparks or flames. Do not breathe vapors or spray mist. Avoid exceeding of the given occupational exposure limits (see section 8). Thoroughly decontaminate all protective equipment after use.
