## 4. First-aid Measures

#### Description of first-aid measures.

#### General advice.

Move victim to a safe isolated area. Immediate medical attention is required. Call a poison control center or doctor for treatment advice.

#### Inhalation.

Move to fresh air. Apply artificial respiration if victim is not breathing. Call a poison control center or doctor for treatment advice.

#### Skin contact.

Wash off immediately with soap and plenty of water. Remove all contaminated clothes and shoes. Remove and wash contaminated clothing before re-use. Call a poison control center or doctor for treatment advice. **Eye contact.**

#### Notes to physician.

Treat symptomatically. Smallest quantities reaching the lungs through swallowing or subsequent vomiting may result in lung edema or pneumonia.

## 5. Fire-fighting Measures

#### Extinguishing media.

#### Suitable extinguishing media.

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide (CO<sub>2</sub>). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

#### Extinguishing media which shall not be used for safety reasons.

Water may be unsuitable for extinguishing fires.

#### Special hazards arising from the substance or mixture.

Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Thermal decomposition can lead to release of irritating and toxic gases and vapors. Most vapors are heavier than air. Vapors may spread along ground and collect in low or confined areas (sewers, basements, tanks). Vapors may travel to source of ignition and flash back. ## 6. Accidental Release Measures

#### Personal precautions.

Stop all work that requires a naked flame, stop all vehicles, stop all machines and equipment that may cause sparks or flames. Do not breathe vapors or spray mist. #### Methods for Containment.

Pick up and transfer to properly labeled containers. Clean contaminated surface thoroughly. Ground and bond containers when transferring material. Take precautionary measures against static discharges. Use personal protective equipment. Remove all sources of ignition.
