4. First-aid Measures

Description of first-aid measures.

General advice.

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice. Call a poison control center or doctor for treatment advice.

5. Fire-fighting Measures

Extinguishing media.

Suitable extinguishing media.

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide (CO₂). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Thermal decomposition can lead to release of irritating and toxic gases and vapors.
