4. First-aid Measures

Description of first-aid measures.

General advice.

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice. Call a poison control center or doctor for treatment advice.

Inhalation.

5. Fire-fighting Measures

Extinguishing media.

Suitable extinguishing media.

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide (CO_2). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

Special hazards arising from the substance or mixture.

Personal precautions.
